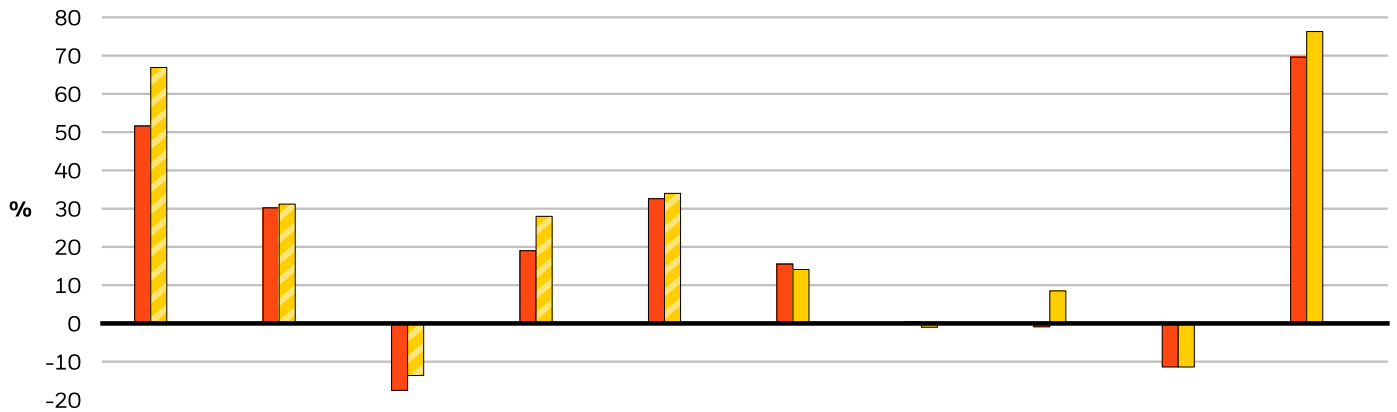

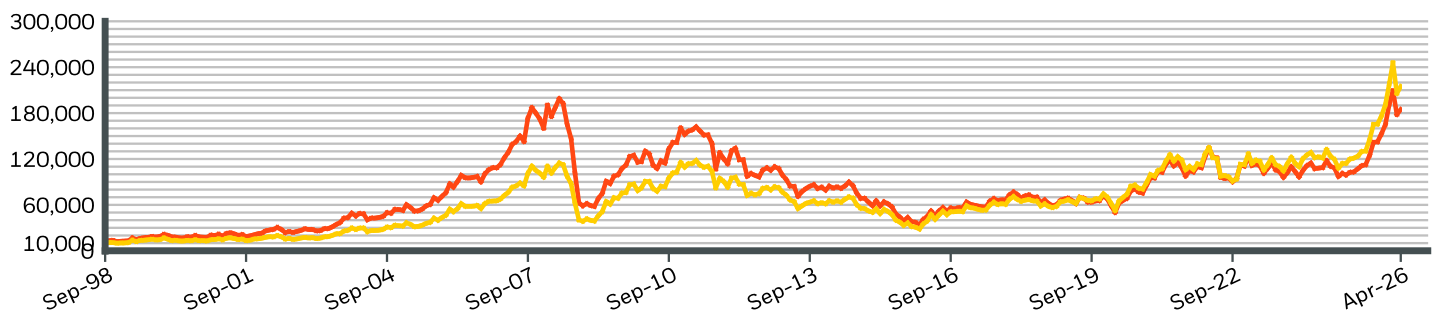

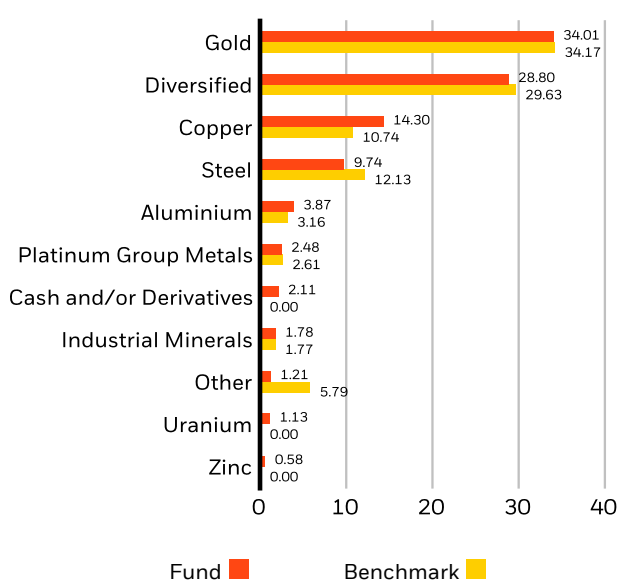

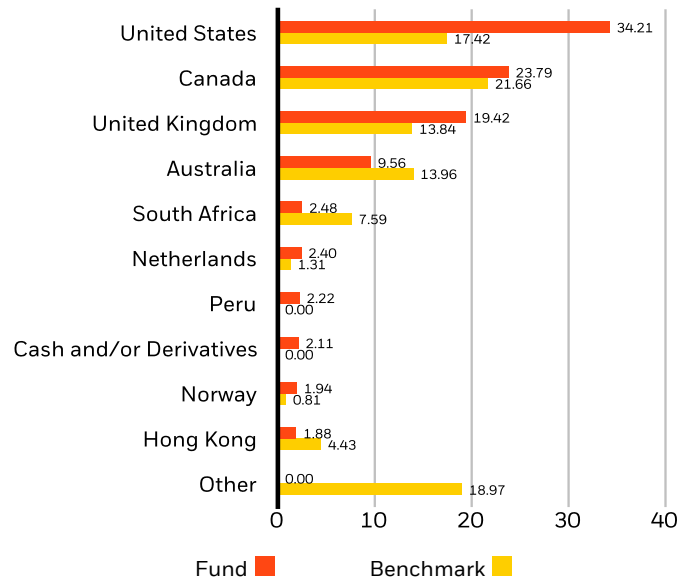

**SECTOR BREAKDOWN (%)**



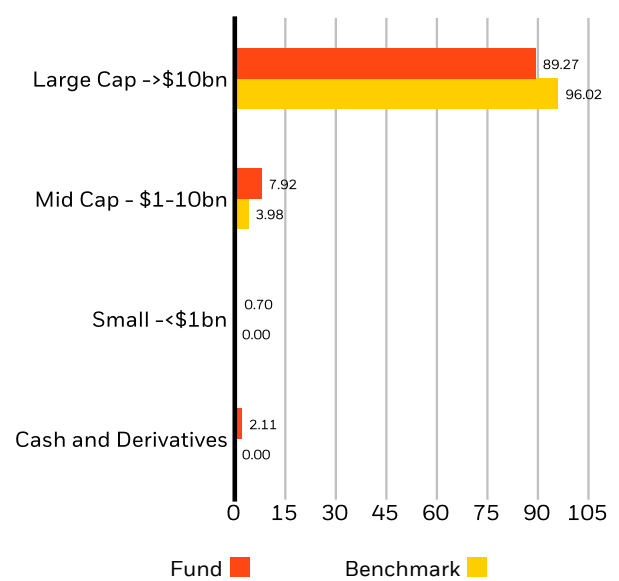
