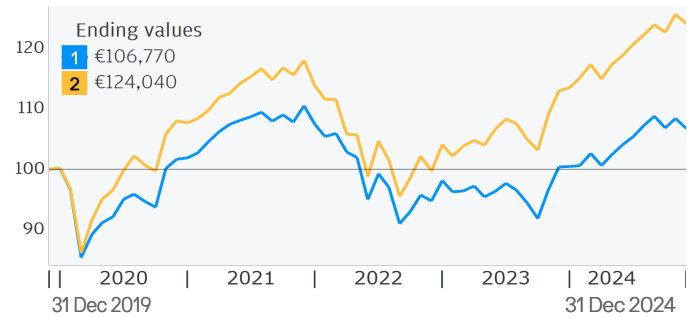

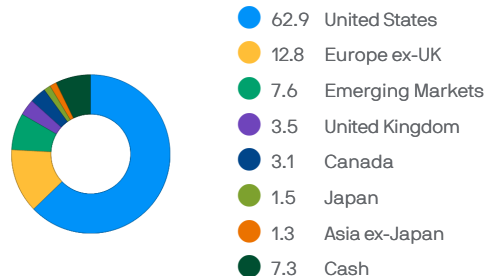

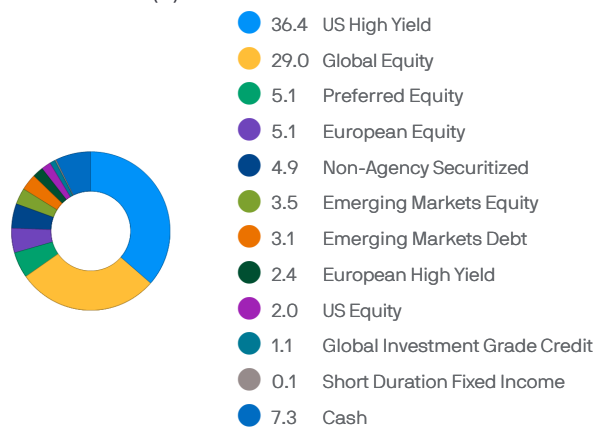

Definitions

NAV Net Asset Value of a fund's assets less its liabilities per Share.

Beta measures a fund's sensitivity to market movements (as represented by the fund's benchmark).
