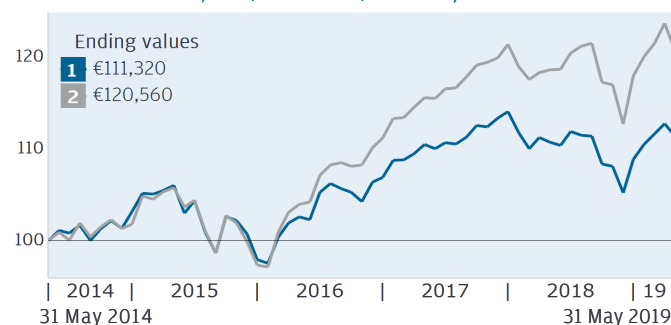

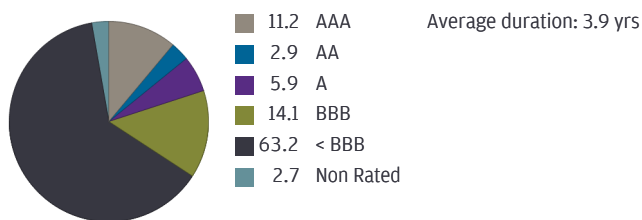

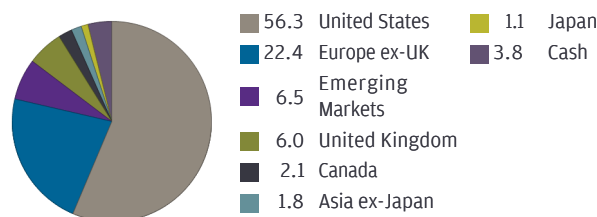

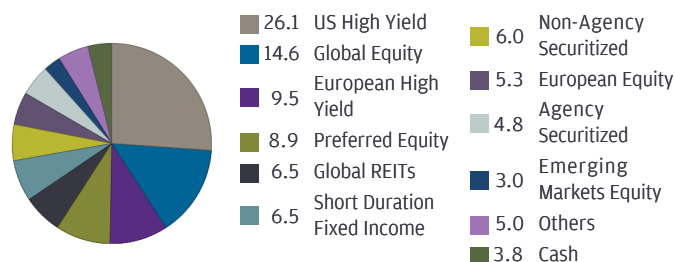
BOND QUALITY BREAKDOWN (%)

Prior to 01/03/11 the composite benchmark was 10% Emerging Markets Global hedged to Euro, 45% BofA Merrill Lynch High Yield BB-B constrained hedged Euro, 10% FTSE EPRA/NAREIT Developed Index hedged Euro, 25% MSCI World hedged Euro and 10% Citigroup Euro Broad Investment Grade. On 01/04/10 part of the element of the composite benchmark for the Fund changed from 10% Global Property Research 250 (Total Return Net) hedged

into EUR to 10% FTSE EPRA/NAREIT Developed Index (Total Return Net) hedged into EUR.

DEFINITIONS

Beta a measure of a fund's sensitivity to market movements (as represented by the fund's benchmark). A beta of 1.10 suggests the fund could perform 10% better than the benchmark in up markets and 10% worse in down markets, assuming all other factors remain constant.

Annualised volatility (%) an absolute measure of volatility and measures the extent to which returns vary up and down over a given period. High volatility means that the returns have been more variable over time. The measure is expressed as an annualised value.

Sharpe ratio measures the performance of an investment adjusting for the amount of risk taken (compared a risk-free investment). The higher the Sharpe ratio the better the returns compared to the risk taken.
