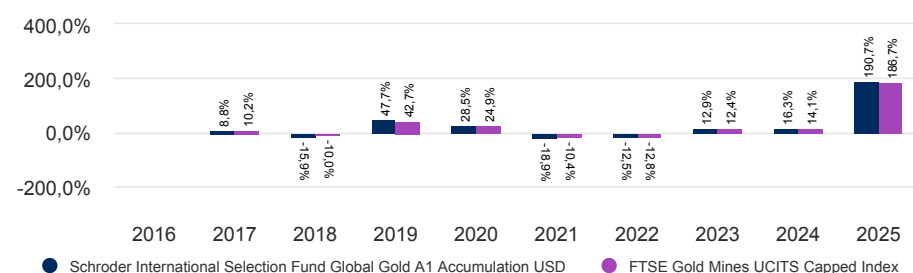

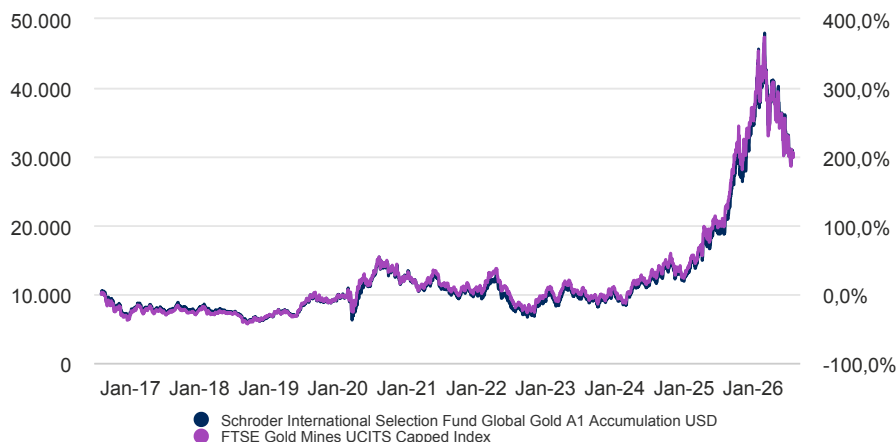

Risk considerations

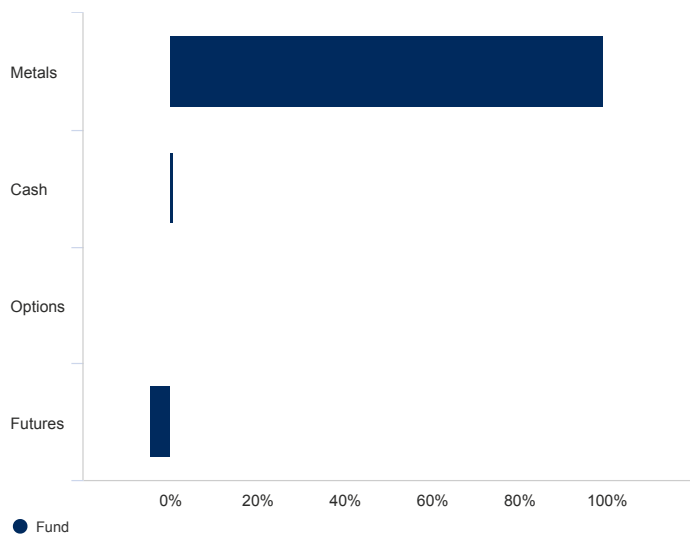

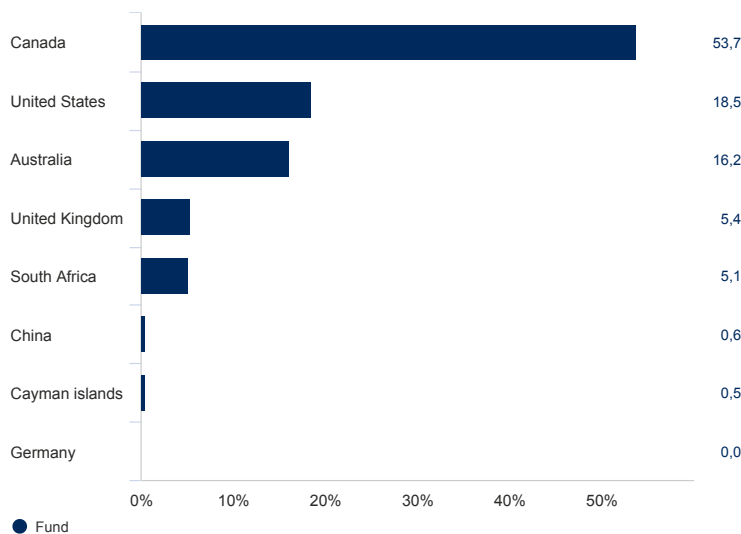
