# Fund for international equities from the "food security" theme

#### Investment Objective

The fund follows a strategy which is aligned with the Sustainable Development Goals ("SDGs") of the United Nations. As such, fund management focuses on companies providing solutions that create positive environmental and social outcomes via their contribution to one or more of the SDGs with simultaneous application of certain minimum exclusion criteria for direct investments. In addition, it is analysed that the companies do not significantly harm the sustainable investment objectives. The fund invests a minimum of 90% of its assets in the shares of international companies which offer products or solutions that actively contribute to positive environmental and social outcomes along the entire food supply chain across production, transportation, quality and safety of food. Up to 50% of the fund's assets may be invested in the emerging markets. The fund's investment objective is to attain long-term capital arowth.




