# 10 QUESTIONS ABOUT THE FORTHCOMING OPERATIONS

## 1. Which stages have already been completed?

The project to optimise our flagship Luxembourg ranges began in 2012 with the merger of 25 sub-funds and will continue throughout the first six months of 2013.

To date this year (25 March 2013), we have already merged two sub-funds in the BNPP L1 SICAV and transferred eight sub-funds from BNPP L1 to PARVEST. This stage only involved sub-funds not registered in Asia.

For the record, the table below details the operations performed:



### 3. What does transferring a sub-fund mean?

Technically, a transfer operation consists of creating an ad hoc sub-fund within PARVEST (which replicates the current features of a BNPP L1 sub-fund, except for the ISIN code), and then activating it by absorbing the existing BNPP L1 sub-fund. This is a technical 1-for-1 merger (no exchange ratio calculation) with a continuous net asset value.

Contrary to cases where the merger of sub-fund A into sub-fund B results in the disappearance of the investment strategy of sub-fund A, in this particular case, the strategy of sub-fund A will continue to exist after its transfer from one SICAV to another.

With the exception of its ISIN code, the characteristics of the transferred sub-fund will be identical to those of the target sub-fund.

- The investment policies will be the same;
- The transferred sub-funds will continue to be managed by the same management team;
- The management fees will be identical;
- The transferred sub-funds will continue to be registered in the same countries if the volumes and the commercial needs so justify;
- The risk category (SRRI) will remain unchanged.

When the operations involve Luxembourg entities and when the characteristics of the transferred and target sub-funds are identical, the past performance of the absorbed sub-fund may be transferred to the target sub-fund. The performance may be included in commercial, marketing and legal documents (KIIIDs), as well as in databases.

### 4. What will be the potential tax impact of these operations?

For both mergers and transfers, there will be no tax impact in most European countries. However, operations of this type may be considered as a taxable event in certain countries depending on the classification of the absorbed sub-fund and the tax residence of the client. We recommend that investors contact Securities Services to determine the tax implications of these operations.

### 5. Will these operations have an impact on the valuation currency of clients' assets?

In the vast majority of cases, these operations will not have any impact on the valuation currency of clients' assets. Even if the base currency of the absorbing sub-fund is different from that of the absorbed sub-fund, clients will continue to hold their positions in the same currency. However, the following exceptions apply:

## 6. Will these operations affect the payment of dividends?

These operations will not affect the payment of annual dividends. As in 2012, the annual dividends for the PARVEST and BNPP L1 sub-funds will be paid out in April.

In terms of the payment of **monthly** dividends, the usual payment schedule applicable to dividends due in May will differ slightly as a result of the planned operations. As announced in the notice to shareholders to be published at the end of April, the schedule will be as follows:

- Record date: 6 May 2013
- Ex-dividend NAV date: 7 May 2013
- Payment date: 14 May 2013

## 7. What impact will these operations have in terms of the risk category?

As explained above (question 3), the risk category of the target sub-fund will be identical to that of the absorbed sub-fund in cases of transfer.

In relation to mergers, in most cases the risk category of the absorbing sub-fund will be identical to that of the absorbed sub-fund. In nine cases the risk category of the absorbing sub-fund will be lower ↘ and it will be higher ↗ in only two cases.




## 8. In which countries will the BNPP L1 SICAV now be registered?




