Q&A Renaming our fund range



1 Background & Objectives

As part of the EC Restructuring agreement, ING Group has agreed to divest its Insurance and Investment Management activities. As of July 2 2014, NN Group N.V. (where ING Investment Management is part of) is listed on Euronext Amsterdam.

This standalone future means that new brand names are going to be used, Investment Management will be rebranded as NN Investment Partners and most of our funds will be renamed as well.

This document gives more details about the renaming of our funds:

- Most funds will change their name from ING to NN
- Some funds will undergo an additional name change
- A minority of funds will not change names

3 Questions & Answers

Question	Answer
When will the renaming take place?	Subject to relevant regulator's approval, renaming of most funds is expected to take place on April 7, provided that an adequate number of shareholders of the corporate fund structure agree thereto in accordance with applicable laws and regulations. For detailed information about the planned renaming, please check the enclosed appendix from page 6 onwards.
How does the renaming work?	As you will see in the appendix, the renaming will take the form of a simple replacement of ING with NN or a more extensive name change. The subfunds with additional name change are highlighted in the appendix.
What are the dealing arrangements for the subfunds?	No dealing arrangements are applicable, because no significant change is made to the funds.
What are the consequences for the investors and what do they need to do?	As a consequence of rebranding investors of corporate fund structures are entitled to vote on the new names at the general meetings. Convening notices will be released in order to inform shareholders of the proposed changes and the applicable procedures.
Will the investment policy be affected by these mergers?	The investment policy will not change.
Will there be a change of ISIN codes?	The ISIN codes of the funds will not change.
