

HARD CLOSE OF PARVEST EQUITY JAPAN SMALL CAP

INFO FLASH #266- FOR PROFESSIONAL INVESTORS

Parvest Equity Japan Small Cap, has seen considerable success in the past few years, attracting much interest from clients due to both the superior performance¹ produced by the investment team at our delegated manager, Sumitomo Mitsui Asset Management ("SMAM") and increasing awareness of the diversification benefits that small caps offer within existing allocations to Japanese equities.

The investment manager considers that allowing further inflows into the fund will weigh on the Parvest Equity Japan Small Cap investment objectives. In order to protect the interests of current investors in the fund, the Board of Directors has therefore decided to limit the size of Parvest Equity Japan Small Cap by suspending new subscriptions in the sub-fund

The Parvest Equity Japan Small Cap sub-fund focuses on small Japanese companies, and/or small companies operating in Japan.

Over the past week, we have seen an extremely high level of subscriptions into the fund. These inflows have taken up the remaining capacity. In order for the investment objectives to remain achievable, to preserve the investment management style and the liquidity of the fund, the management company has come to the conclusion that is necessary to close the fund to further investments.

Investors are reminded that we continue to offer broader access to the Japanese Equities through the Parvest Equity Japan.

As a consequence, all subscriptions and conversions will be suspended from 30th June 2017 after the cut-off and until further notice.

NAVs from July 3rd, 2017 onward will continue to be calculated and redemption orders will remain possible.
